In a nutshell, the GDPR is a new data protection law, coming into force on 25 May 2018, which applies to all businesses operating within the EU. Yes. The GDPR applies wherever you are processing 'personal data'. This means if you can identify an individual either directly or indirectly, the GDPR will apply - even if they are acting in a professional capacity. So, for example, if you have the name and number of a business contact on file, or their email address identifies them (eg initials.lastname@company.com), the GDPR will apply.
