The feudal system of land tenure was brought to an end on 28 November 2004 when The Abolition of Feudal Tenure etc. (Scotland) Act 2000

was brought into force. On that date, the Act replaced the feudal system with a system of outright ownership of land. All superiority interests in land were extinguished.

### **Abolition of Feudal Tenure etc.**

#### **(Scotland) Act 2000**

Abolition of the feudal system will not affect property held allodially by the Crown which has never entered a feudal chain. Allodial tenure is complete, or absolute, ownership of property where there is no superior/vassal relationship. 189. The prerogative powers of the Crown will be completely unaffected by the Act.
