Kasambahay or household helpers have always been there to help us with our daily lives. For long, they had been seen as conventional workers with very little rights recognized by their employers. However, as Republic Act 10361, or the Kasambahay Law had been passed household helpers were given equal rights just like ordinary employees.

Kasambahay benefits and social contributions Under the Kasambahay Law, employers must register their kasambahays as members of SSS, PhilHealth, and Pag-IBIG. They are also required to shoulder premium payments or contributions. But if the household helper is receiving a wage of Php5,000 and above per month, they shall pay their appropriate share.

For example, if a kasambahay has an MSC of Php 5,000, the total monthly contribution is Php 610 (Php 200 employee's share + Php 400 employer's share + Php 10 EC contribution). This is the amount the employer must remit to the SSS, which is posted on the kasambahay's SSS account after payment.

SSS contributions are mandatory for household helpers under Batas Kasambahay. Under SSS law, drivers are also mandated to contribute to the SSS. For helpers with salaries below P5,000, employers will shoulder the whole cost of the contribution.

RA 11199, which requires SSS to pay unemployment benefits to jobless members, is the same law that raises the SSS contribution rate from 11% to 12% in 2019, 13% in 2021, 14% in 2023, and 15% in 2025. How much is SSS for kasambahay? If your helper's salary is Php8,000, you will pay SSS Php650 while the kasambahay will shoulder Php320.

SSS Contributions Table and Payment Deadline 2020 - SSS

... Under the Implementing Rules and Regulations (IRR) of the Kasambahay Bill, SSS, Pag-Ibig and PhilHealth have a period of six months from IRR promulgation to set up a unified system of registration and enrollment. The IRR was promulgated on May 9, 2013. This means that by November 2013, we should have a one-stop shop to register for these agencies.

Household employers can register their helpers not only with the Pag-IBIG Fund but also with the SSS and PhilHealth through the Kasambahay Unified Registration online facility. You must be a registered member of the three government agencies before you can proceed with your kasambahay registration.

GABA Y - Social Security System

RA 7655 (Aug. 19, 1993) requires the mandatory SSS coverage of "househelpers (who are) receiving at least P1,000." Accordingly, the SSS requires the payment of contributions/premiums from the start of the kasambahay employment, not from the time the new law came into full force and effect.

To make registration into SSS, Pag-ibig, and Philhealth easier for both employer and household helper, the government created the Kasambahay Unified Registration System. This system ensures that the household helper will be registered as a member in all three agencies through one registration instead of three.

SSS also released a Circular no. 2019-006 for the new SSS contribution schedule applicable to household employers and kasambahay members. Under the Kasambahay Law, the employer shall pay the whole contribution if the kasambahay earns below Php 5,000.

New SSS Contribution Table 2019: Bigger and Better Benefits

As a member of SSS, a kasambahay is entitled to seven benefits, including sickness, maternity, unemployment, disability, retirement, funeral and death claims. Kasambahays are also covered by the Employees' Compensation Program for work-related illnesses or accidents.
