When a dispute arises, parties will use conciliation as a type of preventative measure. Mediation, on the other hand, shares more similarities with arbitration because it attempts to stop a dispute that's already started.

Mediation is a voluntary process led by an impartial third party that organisations can use to resolve conflict. Conflict can occur in any employment relationship and is best dealt with early at source. If left unchecked, it can fester and escalate, potentially leading to grievance and discipline procedures or employment tribunals.

When there's a disagreement ('dispute') between 2 or more people or groups, we can try to help both sides come to an agreement. This is called 'mediation'. Mediation cannot be used if a claim has been made, or could be made, to an employment tribunal about a dispute. Mediation is held by a neutral person (a 'mediator').

In case of conciliation and mediation the confusion is more as the terms are often used as synonyms. However, the Arbitration and Conciliation Act, 1996 clearly used these two terms as separate.Section 30(1) have used these two as two separate methods and the same is mentioned under Section 89 of the Civil Procedure Code (Amendment) Act, 1908.

Essentially, conciliation is much the same as mediation – a conciliator, like a mediator, is an independent, impartial third party who helps people resolve a dispute. It's just that, in some particular types of dispute resolution, the term ‘conciliation’ is used rather than ‘mediation’.

The main difference between conciliation and mediation proceedings is that, at some point during the conciliation, the conciliator will be asked by the parties to provide them with a non-binding settlement proposal. A mediator, by contrast, will in most cases and as a matter of principle, refrain from making such a proposal.
