Race Matters in Jury Selection

The estimated impact of the racial composition of the jury pool on trial outcomes is statistically significant and leads to three main conclusions: (i) there is a significant gap in conviction rates for black versus white defendants when there are no blacks in the jury pool, (ii) the gap in conviction rates for black versus white defendants is eliminated when there is at least one black member of the jury pool, and (iii) conviction rates for white defendants are significantly
