The BIG EAST began its Academic Award programs in 1987-88. To be eligible for the honor, a

nominee must have competed in a BIG EAST-sponsored sport, attained a minimum grade-point average of 3.00 for the preceding academic year, and completed a minimum of two consecutive semesters or three consecutive quarters of academic work, with a total of 18 semester or 27 quarter credits, not including remedial courses.
