Bid Documents In a continuing effort to streamline construction contract timelines and close-out requirements for City projects managed by the Engineering Department, please be advised that as of February, 2009 the following changes will be implemented in the execution of all new construction contracts:

General Conditions - City of El Paso

The Contract Documents form the Contract between the City and the Contractor and consist only of those documents listed under the definition of “Contract Documents” in the General Terms and Conditions of the Contract. The Contract represents the entire and integrated agreement between the parties and supersedes any prior negotiations, representations, or

AGREEMENT BETWEEN THE CITY OF CAMBRIDGE AND CONTRACTOR

DEFAULT: In case of failure to deliver goods or services in accordance with the contract terms and conditions, the City, after due oral or written notice, may procure them from other sources and hold the contractor responsible for any resulting additional purchase and administrative costs. This remedy shall be in addition to any other remedies which the City may have.

General Terms & Conditions - City of Chesapeake, Virginia

On 19 September 2017, Ofcom revoked the general conditions of entitlement (the ‘general conditions’) set out in the notification published by the Director General of Telecommunications on 22 July 2003 with effect from 1 October 2018 and set revised general conditions with effect from the same date.

General Conditions of Entitlement - Ofcom

1.3 The General Terms and Conditions (GTC) for the City and County of Honolulu (City) apply to all goods and services, construction, and professional services contracts entered into with the City or any other contract which incorporates the GTCs by reference. Unless indicated otherwise, each section of the GTCs apply to all contracts.

3.6 Suspension of Work for Construction Contracts

Person or firm, under contract with the City, to provide professional services during construction and its authorized representatives. If a Design Consultant is not employed for services during construction, Project Manager will perform duties of Design Consultant designated in the Contract in addition to usual duties of Project Manager.
