in the dark days of 1940 and 1941; Roosevelt's steady hand before and after the United States entered the war—and puts them in real human context. Hastings also illuminates some of the darker and less explored regions under the war's penumbra, including the conflict between the Soviet Union and Finland, during which the Finns fiercely and surprisingly resisted Stalin's invading Red Army; and the Bengal famine in 1943 and 1944, when at least one million people died in what turned out to be, in Nehru's words, "the final epitaph of British rule" in India. Remarkably informed and wide-ranging, *Inferno* is both elegantly written and

cogently argued. Above all, it is a new and essential understanding of one of the greatest and bloodiest events of the twentieth century.

The divisional sign, of a red circle on a black background which gave the division its nickname, was selected after the first selection of a boar's head was deemed offensive to Moslem soldiers and every other animal suggested had already been selected by other newly raised divisions. Between 1940 and 1941 the 5th

After periods in Egypt, Cyprus and Syria, by 1942 it was involved in the fighting in the Western Desert of North Africa and the withdrawal of the Allied troops to El Alamein. After the Japanese had been defeated in the Battle of the Admin Box the division was airlifted north to take part in the Battle of Imphal and the Battle of Kohima. Thereafter, the division was almost constantly involved in the advance through central Burma until fighting ended with the Japanese surrender in August 1945
