Indirectly, at least, the Constitution provides the federal government with power to regulate on behalf of environmental quality, but it also sets limits on the power. It sets limits, likewise, on the regulatory power of the states. What it does not do, at present, is grant the "constitutional right to a clean environment" so avidly sought in the heyday of environmental concern, the decade of the 1970s.
