a General Circular No. 32/2014 dated 23 rd July 2014 in relation to the clarification on transitional period for resolutions passed under the Companies Act, 1956. In its Circular, Ministry has stated as follows:

Ordinary and Special Resolutions under the Companies Act ...

The Indian Companies Act, 1956 has introduced a new type of resolution for the passing of which special notice has to be given. Some matters specified in the Act cannot be moved for discussion at 3 General Meeting unless a special notice is given to the company.

Resolutions Recognised by Companies Act: 3 Types

MCA on July 23, 2014 vide General Circular No 32/2014 clarified that resolutions passed under the relevant provisions of 1956 Act during the period from September 1, 2013 to March 31, 2014 can be implemented in accordance with the provisions of 1956 Act notwithstanding the repeal of the said provisions, provided implementation of the resolutions commenced before April 1, 2014. This transitional arrangement will be available upto expiry of one year from the passing of the resolution or six ...
