According to contract law, an agreement made between two or more people or business entities, in which there is a promise to do something in return for a gain or advantage, is legally binding.

Example Answers to Questions on Offer and Acceptance. “Offer” and “Acceptance” are the process by which a buyer and seller create a binding legal contract. This process typically begins when a prospective buyer makes an offer. Then, the seller either accepts it, rejects it, or rejects it and makes a counter offer.

Example Answers to Questions on Offer and Acceptance
“If...a consideration of the terms of the contract, in the light of the circumstances existing when it was made, shows that they never agreed to be bound in a fundamentally different situation

which has now unexpectedly emerged, the contract ceases to bind at that point – not because the court in its discretion thinks it is just and reasonable to qualify the terms of the contract, but because of its true construction it does not apply in that situation.”

There are three basic elements to the formation of a simple valid contract. First the parties must have reached agreement (offer and acceptance).
