If the homeowner properly requests mediation, the foreclosure process comes to a halt until mediation is complete. The mediation will typically be held within 60 days of receipt of the borrower’s written request and fee. Mediation consists of a face-to-face meeting between the homeowner and the lender and is overseen by an Administrative Law Judge.

The federal Limiting Investor and Homeowner Loss in Foreclosure Act (S. 222) is modeled after the Rhode Island loss mitigation program (the subject of the aforementioned legal battle) and a similar New York mediation program.
