The Uniform Marriage and Divorce Act, which is also sometimes referred to as the Model Marriage and Divorce Act, was drafted up back in 1970 and was later amended in 1973. It was the work of the National Conference of Commissioners of Uniform State Laws, otherwise known as the NCCUSL. Along with the NCCUSL, committee members

appointed by the American Bar Association were also tasked with working on the statute.
