In California, escrow processing can be performed under various forms of licensure. Most commonly, real estate related escrows are performed by independent escrow companies licensed by the California Department of Business Oversight and title insurance companies licensed by the California Department of Insurance. Real estate brokers licensed by the California Department of Real Estate can also perform escrows, but only in transactions where the broker is acting as an agent.

At its essence, escrow is the process whereby parties to the transfer

or financing of real estate deposit documents, funds, or other things of value with a neutral and disinterested third party (the escrow agent), which are held in trust until a specific event or condition takes place according to specific, mutual written instructions from the parties.

Escrow is when a neutral third party holds on to funds during a transaction. In real estate, it's used as a way to protect both the buyer and seller during the home purchasing process.
