Texas is one of a few states that establishes parenting/visitation orders as part of the child support establishment process. In most states, parents must pay a separate filing fee to get a parenting time order. District or county courts handle visitation enforcement cases in Texas. Child support courts cannot handle these issues.

Enforcement of Visitation | Texas Access

Filing for Child Custody in Texas Parents can file a custody case in Texas if the child resides in the state or the child resided in the state for six months

before the custody case. They may also file if the child's parents have a connection with Texas besides physically living there, such as a job, or if evidence is available in the state concerning the child's care, education, etc.
