While there is no specific rule, it's recommended to use your best 2 to 4 character reference letters in court for a criminal or traffic offence. A Judge or Magistrate in court deal with many cases in a day. Court sits between 9:30am – 4pm. There is usually a morning tea break from 11:30am-12pm, and a lunch break from 1pm-2pm.

How to Write Good Character Reference Letters for Court ...

Magistrates in the court take character references into consideration when handing down a sentence for someone found guilty of a crime. The purpose of a character reference is to provide insight into the character of the person and to portray how he is viewed by the community.

How to write a character reference for court

Although the character reference for court is addressed to the Magistrate or Judge, it should not to be sent directly to the court. Hand it to the accused or to the lawyer representing the accused. They will check whether the reference can be helpful to the case and whether it is necessary for the type of offending involved.

Character Reference letter for Court and templates

For a Local Court, the character reference should be addressed to “The Presiding Magistrate.” For a District or Supreme Court, address it to “The Presiding Judge.” The salutation (where you would normally put Dear Sir / Dear Madam) should be “Your Honour.” The reference should be typed. The reference should be on official letterhead, if possible.

The letter is written with the purpose of character assessment for any concerned person against whom any trial is being conducted in the court.

1. The character reference for Court should be addressed “To the Sentencing Magistrate” or “To the Sentencing Judge”. Who the character reference is addressed to depends on which Court the defendant is going to. If the matter is in Queensland in the Magistrates’ Court the character reference should be headed “To the Sentencing Magistrate”.
