Developing Case Conceptualizations and Treatment Plans

The Biopsychosocial

Model and Case Formulation (also known as the Biopsychosocial Formulation) in psychiatry is a way of understanding a patient as more than a diagnostic label. Hypotheses are generated about the origins and causes of a patient's symptoms. The most common and clinically practical way to formulate is through the biopsychosocial approach, first described in 1980 by George Engel.

Biopsychosocial Model and Case Formulation - PsychDB

The therapist uses the formulation to aid the work of developing a treatment plan and obtaining the patient's consent to it. As treatment proceeds,
