### **Standard Visitation Child Custody - South Carolina Divorce**

The non-custodial parent shall have a four (4) week visitation each summer for children four (4) years of age or older in which there shall be a visitation period longer than two (2) week at one time. For children two (2) and three (3) years of age, the non-custodial parent shall have two (2) weeks of visitation.

If the parties are unable to agree, the following Guidelines provide a basic minimum structure for reasonable visitation in all cases other than joint custody with equal time-sharing. The Court encourages all parents to consider all parenting and custodial options in order to arrive at the best interests for their children and in order to minimize the trauma of divorce for those children.
