SCORING METHODS OF POLYSOMNOGRAPHY FOR DIAGNOSIS OF SLEEP APNEA IN ADOLESCENTS.

Purpose: Both respiratory scoring rule for children and adults can be used for adolescents in 2007 and 2012 American Academy of Sleep Medicine (AASM) scoring manuals. We evaluated the differences in scoring method of polysomnography using both 2007 and 2012 AASM scoring manuals when pediatric and adult scoring rules are adopted for adolescents for the diagnosis of sleep apnea. **Methods:** 106 Korean subjects with ages between 13 and 18 years old were enrolled. All subjects underwent overnight polysomnography in a sleep laboratory. Data were scored by both

pediatric and adult rules in 2007 and 2012 AASM scoring manuals. Results: Both pediatric and adult apnea hypopnea indices (AHI) using 2012 method were significantly higher than those using 2007 method. Difference of AHI among pediatric versus adult score in 2012 method was markedly decreased than that in 2007 method. There was a significant discordance of diagnosis for sleep apnea between pediatric and adult scoring rules in 2012 method. Conclusions: Both pediatric and adult rules could be used for the diagnosis of adolescent sleep apnea in 2012 method. However, there was significant discordance of diagnosis for sleep apnea between pediatric and adult rules in 2012 method. This might be due to different cut-off values of AHI for diagnosing sleep apnea among pediatric (u22651) and adult (u22655) rules. Further studies are needed to determine which cut-off value is more reasonable for diagnosing sleep apnea in adolescents.

The WHO Regional Office for Europe set up a working group of experts to provide scientific advice to the Member States for the development of future legislation and policy action in the area of assessment and control of night noise exposure. The working group reviewed available scientific evidence on the health effects of night noise, and derived health-based guideline values. In December 2006, the working group and stakeholders from industry, government and nongovernmental organizations reviewed and reached general agreement on the guideline values and key texts for the final document of the "Night noise guidelines for Europe". Considering the scientific evidence on the

thresholds of night noise exposure indicated by "L_{night,outside}" [L suffix night,outside] as defined in the Environmental Noise Directive (2002/49/EC), an L_{night, outside} of 40 dB should be the target of the night noise guideline (NNG) to protect the public, including the most vulnerable groups such as children, the chronically ill and the elderly. "L_{night,outside}" value of 55 dB is recommended as an interim target for the countries where the NNG cannot be achieved in the short term for various reasons, and where policy-makers choose to adopt a stepwise approach. These guidelines are applicable to the Member States of the European Region, and may be considered as an extension to, as well as an update of, the previous WHO "Guidelines for community noise" (1999). Manual approaches to sleep classification have been in use for over 40 years, and in 2007, the American Academy of Sleep Medicine (AASM) published a new sleep scoring manual. Over the years, many attempts have been made to introduce and validate machine learning and automated classification techniques in the sleep research field, with the goals of improving consistency and reliability. This thesis explored and assessed the use of automated classification systems with the updated sleep stage definitions and scoring rules using neuro-fuzzy system (NFS) and support vector machine (SVM) methodology. For both the NFS and SVM classification techniques, the overall percent correct was approximately 65%, with sensitivity and specificity rates around 80% and 95%, respectively. The overall Kappa scores, one means for evaluating system reliability, were approximately 0.57 for both the NFS and SVM, indicating moderate agreement that is not accidental. Stage 3 sleep was detected with an 87-89% success rate. The results presented in this thesis show that the use of NFS and SVM methods for classifying sleep stages is possible using the new AASM guidelines. While the current work supports and confirms the use of these classification techniques within the research community, the results did not indicate a significant difference in the accuracy of either approach -- nor a difference in one over the other. The results suggest that the important clinical stage 3 (slow wave sleep) can be accurately scored with these classifiers; however, the techniques used here would need more investigation and optimization prior to serious use in clinical
