By contrast, an involuntary dismissal request may be filed by the defendant, or the person against whom the case was filed. A judge can dismiss a claim with or without prejudice. A dismissal without prejudice is one where the plaintiff is allowed to amend the complaint or refile it. A dismissal with prejudice kills the claim. Dismissal of all the claims with prejudice ends the case. The plaintiff cannot refile the lawsuit. The only thing left for him to do is to appeal.

How To Defeat The Motion To Dismiss For Failure To State A ...

The plaintiff's civil rights pleading was 150 pages and described by a federal judge as "inept". Nevertheless, it was held "Where a plaintiff pleads pro se in a suit for protection of civil rights, the Court should endeavor to construe Plaintiff's Pleadings without regard to technicalities."

Subject to the provisions of Rule 23 (e), of Rule 66, and of any statute of the United States, an action may be dismissed by the plaintiff without order of court (i) by filing notice of dismissal at any time before service by the adverse party of an answer or of a motion for summary judgment, whichever first occurs, or (ii) by filing a stipulation of dismissal signed by all parties who have appeared in the action.

In some prison cases filed pro se by prisoners, the defendants will file a "motion to dismiss for failure to state a claim." In cases filed in federal court under 42 U.S.C. §1983, a motion to dismiss for failure to state a claim is filed under Federal Rule of Civil Procedure 12 (b) (6), which I will call by the shorthand "Rule 12 (b) (6)."

In the alternative, plaintiff asks that the court issue an order to whomever the court recognizes as her counsel to file this motion on her behalf, or withdraw officially from representing plaintiff so that she can proceed pro se and file this motion herself. Plaintiff also asks that the court vacate its order dismissing her Second Amended Complaint, or in the alternative allow her dismissal to be "without prejudice".
