If you have caused the accident yourself, and no-one else is to blame, it will not usually be possible to make a personal injury claim. This is because, in most cases, the claim is made against the insurance company of the person who caused the accident.

Yes - if you've been in an accident, you do have to tell your insurer. You should send your insurer a letter telling them what's happened. But make it crystal clear that this is for 'information only' and you don't wish to make a claim. This should ensure your insurer doesn't settle with the other party's insurer without your knowledge.

I've had a car accident, do I have to claim on my insurance?

The most common claim in a personal injury case is negligence and the time limit for this is 3 years.

This means that court proceedings must be issued within 3 years of you first being aware that you have suffered an injury. In some cases, a court may decide to extend a time limit, depending on the circumstances of the case.

In a personal injury compensation claim, causation is proved by medical evidence. The claimant must prove that the injury was caused, or at least contributed to, by the accident.
