Pregnancy Discrimination And Parental Leave

The person could take their case to an employment tribunal if they believe they've been discriminated against because of pregnancy or maternity. Discrimination includes: dismissing them; not offering them a job; changing their pay or other terms; forcing them to work while on maternity leave; stopping them returning to work because they're breastfeeding

Discrimination because of pregnancy or maternity: Managing ...

Pregnancy and maternity discrimination is when you're treated unfairly because you're pregnant, breastfeeding or because you've recently given birth. You must suffer a disadvantage as a result of the unfair treatment. The law says you've been treated unfavourably.

Pregnancy and maternity discrimination - Citizens Advice

The law says that it is pregnancy discrimination to treat a woman unfavourably on the grounds of her pregnancy or because she wants to take or has taken maternity leave (Equality Act 2010 s.18). To show discrimination a woman does not have to compare herself to how a man might have been treated but she needs to show that the treatment was because of her pregnancy.

Pregnancy discrimination - Maternity Action

The Family and Medical Leave Act (FMLA) requires by law that non-exempt employers must provide up to 12 weeks of leave (typically unpaid) for parental leave following the birth or adoption of a child.

Protection from dismissal, detriment or discrimination by reason of pregnancy or maternity. Eligibility. To qualify for statutory maternity leave (SML) you need to: Be an employee (not a worker); and; Give the correct notice: a. At least 28 days prior to taking statutory maternity leave; and b. Providing the employer with proof of pregnancy.

Maternity leave and rights

You were not offered a suitable alternative vacancy (if one existed) during maternity, adoption or shared parental leave. Pregnancy/maternity discrimination. You were selected for redundancy because of pregnancy or maternity leave or for other prohibited reasons such as having taken time off for antenatal appointments.

Discriminatory Parental Leave Policy In addition to providing medical leave for women with pregnancy-related conditions and for new mothers to recover from childbirth, an employer provides six additional months of paid leave for new mothers to bond with and care for their new baby. Pregnant employees or new mothers are not exempt from being selected for redundancy in a genuine redundancy situation. However, unscrupulous employers sometimes use a sham

redundancy as an excuse to dismiss an employee who is pregnant or on maternity leave. This amounts to unfair dismissal and direct pregnancy and maternity discrimination.

Discrimination against a woman occurs if she is treated unfavourably during the protected period because of the pregnancy, pregnancy-related illness, or because she is exercising, or has exercised maternity leave rights.

treatment and victimisation. This is different to how the other protected characteristics are covered, but in most cases the protections are broadly similar or stronger for pregnancy and maternity.
