Description. Presenter Details. 21 CFR part 111 (“the DS cGMP rule”) requires persons who manufacture, package, label, or hold a dietary supplement to establish and follow current good manufacturing practice-the cGMPs.

This is to ensure the quality of the dietary supplement and to ensure that the dietary supplement is packaged and labeled as specified in the master manufacturing record.

Federal GMPs for Dietary Supplements. The U.S. Food and Drug Administration's (FDA) final regulation on good manufacturing practices (GMPs) for dietary supplements established stringent requirements for companies involved with the manufacturing, packaging, labeling and holding of dietary supplements. Under the rule, manufacturers are required to

evaluate the identity, purity, quality, strength, and composition of their dietary ingredients and dietary supplements.

After a relatively quiet 2017-2018 marked mostly by noticeable decline in FDA inspections of dietary supplements for GMP (good manufacturing practices) compliance, anecdotal evidence indicates the agency has returned to the field and that many of the issues that existed before continue to be gnawing problems for the industry today.

The updates to the NSF/ANSI 173 GMP registration for dietary supplements audits implemented in 2019 were the first step toward this new standard, and incorporated many of the audit requirements of NSF/ANSI 455-2.
