Possession process

The defence must be in the standard form, using form N11R (or form N11B in case of accelerated possession proceedings).

Alternatively, if the claim has been started using the Possession Claim Online (PCOL) service, the defendant can file a defence, or a defence and counterclaim, using PCOL (see the page on Online claims for more information).

The stay on possession proceedings which was imposed originally by CPR PD 51Z and thereafter embodied within CPR 55.29, expired on 20 September 2020. Since then, claimants have been able to either reactivate their claims if still ongoing and brought prior to 3 August 2020. Other claimants have been gradually receiving dates for hearings.
