Private fostering is an arrangement whereby a child under the age of 16 (or 18 if the child has a disability) (S.66 Children Act 1989) is placed for 28 days or more in the care of someone who is not the child's parent (s) or a 'connected person'. A connected person is defined as a 'relative, friend or other person connected with a child'.
