In a lease option, the buyer (the property renter) pays the seller (the property owner) option money for the right to purchase the property later. Lease option money can be substantial. The buyer also agrees to lease the property from the seller for a predetermined rental amount during the term of the lease option agreement.

An option agreement is a contract between the owner of a property and a potential buyer, which gives the potential buyer the right to purchase the property during a specified time, called the “option period”, for an agreed price. Residential Lease with an Option to Purchase Agreement

A lease with an option to purchase form is a document which is to be used by landlords and property owners who will allow their tenants to purchase or buy the property which is being leased to them. However, the purchase offer is only limited which means that the tenant must make a decision within the period when the offer was provided by the landlord.

A lease option agreement involves a tenant being given the option to buy a property at an agreed price at the end of a given rental period, usually three to six years.
