Sample of Letter of Resolution | Free Sample Letters

A written resolution is passed by the eligible members of the company indicating their agreement to it on a signed document which indicates the resolution to which they are agreeing. For an ordinary resolution: Over 50% of the eligible members of the company must agree to an ordinary resolution before it can be passed. For a special resolution: At least 75% of the eligible members of the company must agree to a special resolution before it can be passed.

Shareholders' Written Resolution (Single Resolution)

This board resolution sample is written as a letter, and addressed to a person or a company. The letter has all the details of the company and the date and venue of the meeting followed by the actual resolution reached at in the meeting. You may also see collection letters. The Companies Act 2006 gives greater prominence to the written resolution and creates some more detailed procedural rules. A provision in the articles of a private company that a resolution cannot be passed as a written resolution is void (sec300), but this applies only to resolutions 'required or provided for in an enactment'.

A resolution may be proposed as a written one by the directors or by the members. The company must send the proposed resolution to every eligible member either in hard copy form, in electronic form or by means of a website. The requirements as to notice and so on, are the same as for a physical meeting.
