Tax Sale Excess Funds. Following a tax sale, any overage of funds, known as 'excess funds,' is placed in a separate account. Per O.C.G.A. § 48-4-5, excess funds may be claimed by the record owner of the property at the time of the tax sale, by the record owner of each security deed affecting the property, and by any other party having any recorded equity interest or claim in such property at the time of the tax sale.

Did you know that in about half of the states in the U.S., when more is bid at tax sale than is owed in back taxes, the overage escheats immediately to the government? In the rest, the tax sale overages are held for at the very least six months for the owner to collect.

What Are the Best States For Tax Sale Overages?

Tax Sale Overage Information. If a property is sold at tax sale and the bid amount is greater than the total taxes, assessments, penalties, and costs due, the resulting excess funds are held in escrow and known as "Overage". According to SC Code of Laws Section 12-51-130, these funds belong to "the owner of record immediately before the end of the redemption period" and are available to be claimed and payable "ninety days after execution" of the tax sale deed.

Tax Sale Overage Information - Oconee County, SC

The record owner of the property at the time of the tax sale may claim the overage only if the property is not encumbered by a mortgage or lien, or if there are funds remaining after the mortgagee has satisfied their secured claim. To receive consideration, all claims should include the following:
