ObamaCare increases taxes on unearned income by 3.8%, and this can add additional taxes to the sales of some homes. However, many limitations apply, so this won't affect most sellers. The 3.8% capital gains tax typically doesn't apply to your primary residence.

The plan was to be funded through a combination of required enrollment, penalties and a 3.8% Net Investment Income Tax and an additional 0.9% Medicare Tax. The Tax Cuts and Jobs Act of 2017 (TCJA), reduced the fine for violating the individual mandate to zero, starting in 2019.
