On June 15 2020, the US Supreme Court decided in *Bostock v. Clayton County* that Title VII of the 1964 Civil Rights Act forbids termination of employees because of their sexual orientation or because they are transgender.. Gerald Bostock and Donald Zarda had each alleged termination from work because of their sexual orientation.

Sexual orientation discrimination is where you are treated unequally because of your sexual orientation, your perceived orientation or the orientation of someone with whom you associate. The Act has deemed that sexual orientation is a 'protected characteristic' and, accordingly, discrimination for this reason is unlawful. Sexual orientation discrimination can arise in any of four ways:

Sexual orientation discrimination - Landau Law Solicitors

The Equality Act 2010 says you must not be discriminated against because: you are heterosexual, gay,

lesbian or bisexual. someone thinks you have a particular sexual orientation (this is known as discrimination by perception) you are connected to someone who has a particular sexual orientation (this is known as discrimination by association) In the Equality Act, sexual orientation includes how you choose to express your sexual orientation, such as through your appearance or the places you visit.

In *Romer v. Evans*, 2112 the Supreme Court struck down a state constitutional amendment that both overturned local

ordinances prohibiting discrimination against homosexuals, lesbians or bisexuals, and prohibited any state or local governmental action to either remedy discrimination or to grant preferences based on sexual orientation.

Both sexual orientation and gender identity discrimination are violations of Title VII of the Civil Rights Act of 1964, a federal law that prohibits employment discrimination on the basis of race, color, religion, sex, and national origin. The first state to prohibit sexual orientation discrimination was Pennsylvania, which enacted a law in 1975 that applied to public sector employers. State-level agencies

Basing federal employment law on a vaguely defined concept such as sexual orientation, especially when our courts have a wise precedent of limiting suspect classes to groups that have a clearly-defined shared characteristic, would undoubtedly cause problems for many well-meaning employers.

An example of indirect discrimination because of sexual orientation is where a club has a policy of offering free membership to all husbands and wives of its members, but not to civil partners. If you think that indirect sexual orientation discrimination might
