A board resolution (bank employees will often call it "BR") is a resolution passed in a Board Meeting authorizing certain persons in a company to open and operate the bank account of a Company (Private Limited or Public Limited) or Limited Liability Partnership (LLP). A company is considered a separate legal entity (consider it as another person), the board resolution is

required for opening a bank account in addition to other documents.
