The law dictates that there is a limit on how much time can pass after a claim arises before it becomes inactionable. The primary body of law on this matter is found within the Limitation Act 1980, the most important part of which is s.2, dictating that actions founded on tort expire after six years have passed from the date on which the cause of action accrued.
