context in which such acts or practices are unfair or deceptive; and (3) a statement as to the economic effects of the rule, taking into account the effect on ...

According to the law, unfair, deceptive, or abusive acts or practices can cause significant financial injury to consumers, erode consumer confidence and undermine the financial marketplace. The potential for UDAAP issues is extensive, and, because the law could apply to virtually any inconsistent, inaccurate or omitted information, the threat of UDAAPs is open-ended.
