Basically, anything the corporate board does must be put in the form of a resolution. The purpose of these resolutions is to create documents that hold the board accountable and that show licensing boards and state and

federal regulators (including the IRS) that the board is acting according to its fiduciary responsibilities.

What to Include in a Corporate Resolution

These resolutions are passed by the board, officially recorded by a corporate secretary and filed among a company's official records. The corporate resolution for signing authority is a specific corporate resolution that authorizes specific corporate officers with the legal standing to sign contracts on behalf of the corporation.

A Directors' Resolution form is used by the board of directors in a corporation to

document decisions and actions (typically) in place of a directors' meeting.. Alternatively, a Shareholders' Resolution is used by shareholders in a corporation to propose amendments, decisions, or changes to the corporation at a shareholders' meeting..
