If you can't reach an early compromise on the issues of custody (who has legal authority over the child and where does the child live), visitation (how often and under what conditions does the noncustodial parent spend time with the child), and child support (whether the noncustodial parent

contributes anything to the costs of raising the child), you will have to submit your dispute to the court system.

Family law mediators, in particular, help parents work through child custody arrangements, parenting time and visitation, child support, and more. The benefits of working with a child custody mediator include an increased willingness—on the part of both parents—to follow the agreed upon arrangement and even saving money (compared to a contentious court battle).

Child Custody Mediation for Visitation Rights

Child Support may be ordered whether the parties exercise shared residential custody or primary residential custody. It is calculated through a formula created by the Kansas Supreme Court. It is based on the income of the parties, the number of children of the parties, other children that the paying party may be financially responsible for, daycare expenses, and health care expenses.

Child Custody, Visitation and Support - KLS

Upon request by one of the parties in a custody suit, Texas law requires the court to interview a child who is at least twelve years old about

their wishes about custody. The court must still make a decision that is in the best interest of the child, but the child can at least have the opportunity to have their preference heard.

The child spends most nights with the parent with "primary custody." As the "primary custodian," you make all the decisions about how to raise your child. The other parent usually has "parenting time" (also called "visitation" in other states)—or the right to spend time with the child, including overnights.

In addition to custody orders, the judge will probably also make child support orders. Keep in mind that a child support order is separate from child custody and visitation, so you cannot refuse to let the other parent see the children just because he or she is not making the child support payments that the court ordered. And

you cannot refuse to pay child support just because the other parent is not letting you see your children.

A Child Custody Agreement is used by parents to lay out the details of how they will co-parent their child or children together even though they are no longer romantically involved. The Agreement addresses issues such as physical and legal custody, visitation schedules, health insurance, college, and, if desired, child support.
