Physician assistants will be permitted to practice at remote sites without requiring approval from the Washington Medical Commission, effective July 1, 2021. The laws and licensure governing physician assistants in chapter 18.71A RCW will replace the osteopathic physician assistant license found in chapter 18.57A RCW, effective July 1, 2022.
