and deliver to said bank a duly signed original of the completed banking resolution as is annexed thereto, and that the authority to transact business, including but not limited to the maintenance of savings, checking and other accounts as well as borrowing by the Corporation, shall be as contained in said resolution with the named officers therein authorized to so act on behalf of the Corporation as specified hereto.

Sample Corporate Resolution to Open a Bank Account ...

A corporate resolution to open a business bank account is a document that clearly shows the bank who has the authority to

start an account on behalf of your corporation. If this information isn't specifically covered in your Articles of Incorporation or bylaws, your bank may require a resolution.

A corporate resolution for a bank account is a statement listing the names of officers authorized to do business on the corporation 's behalf. Corporations need bank accounts to create a separate holding place for money associated with their business, and banks must know who represents the corporation as they do business together.

What Is a Corporate Resolution for a Bank Account?

The banking resolution document is drafted and adopted by a

company's members or Board of Directors to define the relationship, responsibilities and privileges that the members or directors maintain with respect to the company's banking needs.

A common example of a corporate resolution is one that notifies a bank that a specific executive in the business has the authority to access corporate funds, sign checks, and acquire loans on behalf of the corporation. 1 Corporations are separate entities from their owners and they have separate liability from these owners.

A board resolution (bank employees will often call it “BR”) is a resolution passed in a Board Meeting authorizing certain persons in a company to open and operate the bank account of a Company (Private Limited or Public Limited) or Limited Liability Partnership (LLP).
