Eu Competition Law Rules Applicable To Antitrust Enforcement

Title VII, chapter 1 of the Treaty on the Functioning of the European Union lays down the basis for Community rules on competition. State aid is prohibited under the Treaty, although exceptions exist because such aid may be justified by, for example, services of general economic interest. It must be demonstrated that they do not distort competition in such a way as to be contrary to the public interest.

New EU platform-to-business rules aimed at enhancing transparency of online platforms for business users are now applicable. Implementation of certain procedural aspects in Luxembourg is pending. An enforcement role is given to the Competition Council. Regulation (EU) 2019/1150 of 20 June 2019 on promoting fairness and transparency for business users of online intermediation services (" Regulation ") has been applicable since 12 July 2020.
