To make a living trust in Georgia, you must create a trust

document and sign the document in front of a notary public. The trust document contains the name and address of both the grantor and the trustee, a list of property along with the name of the person the grantor wishes it to be conferred upon and the name of the person who will inherit the property placed in the trust.

your witnesses must sign your will in front of you. Ga. Code Ann. § 53-4-20. Do I Need to Have My Will Notarized? No, in Georgia, you do not need to notarize your will to make it legal. However, Georgia allows you to make your will "self-proving" and you'll need to go to a notary if you want to do that. A self-proving will speeds up probate because the court can accept the will without contacting the witnesses who signed it.
