Torts are categorized into Intentional Torts (a person had substantial knowledge that his/her actions would result in harm), Strict Liability Torts (Torts which focus only on the physical aspect of the wrongful act), and Negligent Torts. When a person commits a Tort, the court will not look at the Tort but at the harm or injury suffered by the victim as a result of that Tort.
