What to Include in a Corporate Resolution

If, under a State law, a corporation may be voluntarily dissolved without the adoption of a corporate resolution or plan simply by complying with certain statutory requirements, and a certificate of dissolution is executed in the form required and forwarded to the proper State official, such action will be considered as the adoption of a plan by a corporation for its dissolution within

the meaning of section 6043 of the [Internal Revenue] Code and the regulations.
