Boyle's law—named for Robert Boyle—states that, at constant temperature, the pressure P of a gas varies inversely with its volume V , or $PV = k$, where k is a constant. Charles's law—named for J.-A.-C. Charles (1746–1823)—states that, at constant pressure, the volume V of a gas is directly proportional to its absolute (Kelvin) temperature T , or $V/T = k$.
