Abstract. Although scholarship in law and development which

explores the relationship between law and social and economic progress has evolved over the last four decades, this area of inquiry remains unfamiliar to many legal scholars, lawyers, and policy makers. Scholars have not yet been able to develop a theory that systematically explains the interrelationship between law and development, which would establish law and development as a robust and coherent academic field.

POSITIVE LAW THEORY. Positive law theory is also called, imperative or analysts law theory. It refers to the law that

is actually laid down by separating "is" from the law, which is "ought" to be. It has the belief that law is the rule made and enforced by the sovereign body of the state and there is no need to use reason, morality, or justice to determine the validity of law. According to this theory, rules made by the sovereign are laws irrespective of any other considerations.

MAJOR THEORIES OF LAW

In 1924, Pashukanis published his seminal work, *The General Theory of Law and Marxism*. This is best known for Pashukanis' formulation of the "Commodity Exchange Theory of Law". This theory was built on two pillars of Marxist

thought: (1) in the organization of society the economic factor is paramount; legal and moral principles and institutions therefore constitute a kind of superstructure reflecting the economic organization of society; and (2) in the finally achieved state of communism ...
