The entry for the employer's payroll taxes expense for the Feb. 28th payroll would include increases (credits) to liabilities for FICA taxes of \$250 (the employer has to match the amount paid by employees), FUTA taxes of \$26 (0.8% × \$3,268), and SUTA taxes of \$176 (5.4% × \$3,268).

A payroll liability can include wages an employee earned but has not yet received, taxes withheld from employees, and other payroll-related costs. These liabilities accompany every payroll you run.
