Case Concerning Certain Property Liechtenstein

In 1945, Czechoslovakia confiscated certain property belonging to Liechtenstein nationals, including Prince Franz Josef II of Liechtenstein, pursuant to the "Beneš Decrees", which authorized the confiscation of "agricultural property" (including

buildings, installations and movable property) of "all persons belonging to the German and Hungarian people, regardless of their nationality".
