Customary Marriage system is one of the five systems envisaged by the Marriage Act, 2014. After the enactment of the Marriage Act 2014, the Registrar in consultation with various stakeholders, drafted the Marriage (Customary) Rules 2017 to operationalize the registration of customary marriages pursuant to the provisions of Section 50 (1) of the said Act.

Admin June 04, 2013. There are different forms of marriages that exist under Kenya Customary Law. (i) A monogamous marriage which is a marriage

between one man and one woman; (ii) Polygamy – whereby a man can celebrate marriage with many women at different times. (iii) Leviratic Marriages – these arise where the husband predeceases the wife and a relative or brother of the deceased husband assumes the role of the deceased.
